### NOTES:

The FA at the meeting on 2<sup>nd</sup> February accepted that with restructure in a seasons time it would be unfair to switch clubs from East to West or West to East where it is known they would be switched back in the new set up, for the 2018/19 season the board set constitutions with this in mind.

**Premier:** Parkway promoted to Step 5, Witheridge reprieved from relegation as no East clubs desire promotion from Step 7, Millbrook Promoted from Step 7.

**East:**

**19 clubs – 17 from this season, plus 2 applicant clubs placed in the division (Elmore from the Devon & Exeter League and Waldon United from the South Devon League).**

**The application from a team in the North Devon League (Braunton) was refused due to the clubs final finishing position. Normally 1 or 2 would be placed in West to give an equal split.**

**As the division has an odd number Torquay United were offered a space in East, (had there not been an odd number Torquay had previously been considered only for the West Division) however we have been informed that Torquay United no longer wish to enter a team.**

**West:**

**16 clubs with Millbrook promoted to Step 6, Illogan relegated (as they asked for in writing by March 31<sup>st</sup>), Bere Alston promoted from the East Cornwall Premier League. The application from a team in the Cornwall Combination League (Carharrack) was refused due to the clubs ground grading report.**

**Key:**

- (1) Godolphin Atlantic & Stoke Gabriel will face financial sanction if not fully compliant with G Grade by September 30<sup>th</sup>. If not compliant by March 31<sup>st</sup> 2019 they may not be accepted for Step 6 in season 2019/20.**
- (2) Millbrook must be fully compliant with G Grade by March 31<sup>st</sup> 2019, if not they may not be considered for Step 6 in season 2019/20.**
